The undersigned undertakes to respect everything undersigned in this form during all the conducted dives/courses carried out with the **Associazione Sportiva Dilettantistica Blue Discovery**.
 Through this statement, the undersigned intends to release **Blue Discovery ASD** from every responsibility about any damages to his person or others, as a result of actions and behaviours chosen by the undersigned and not in line with teachings and suggestions of **Blue discovery ASD** and his staff.
 To this purpose, during every phase of the diving/training, the undersigned undertakes to:

- Scrupulously respect everything explained and suggested by the Instructor or Guide during the course/dive/excursion;
- During every dive/excursion phase, both in delimited and open waters, from the pre-dive planning to the post-dive procedures, put into action all the behaviours and actions planned by the Instructor/Guide;
- During the 2nd point phases, never exceed the maximum depth of the instructor/guide and the maximum depth provided by his/ her scuba licence;
- During the 2nd point phases, carry out the exercises only after having received the instructions from the Instructor;
- Always stay close to the dive flag and float, (maximum 50m to it).
- During every dive or snorkelling excursion never do apnea (BRATHE CONTINUOSLY AND NEVER HOLD YOUR BREATH)
- Never put in action any behaviour which can be dangerous for his own safety and of the other participants, including the instructor and his staff.
- During the excursion/dive never will go too far away from the instructor/guide.
- The equipment provided is clean and in decent shape
- Take care of the equipment used during the activities, and I will be economically responsible for damages, thefts or loss of any part of the equipment.
- I can swim, I will put the life vest and the leash during the SUP excursion, I won't use the SUP board with strong wind.

Blue Discovery ASD informs the undersigned that it is possible to acknowledge the provisions of articles 7, 13, 23, 26 of the DLgs. 30.6.2003 n. 196 and GDPR 679/2016.

The undersigned declares to know his own rights concerning the processing of his personal data; in particular it declares itself informed on the articles. 7, 13, 23, of Legislative Decree 30.6.2003 n. 196, on the GDPR 679 / 2016e on the purposes of treatment.

He declare that have read the Privacy information provided by ASD Blue Discovery on the website www.bluediscovery.it.

He authorizes Blue Discovery ASD for the storage and communication of its own data, even sensitive ones, should such communication be necessary for the fulfillment of the formalities concerning the relationship. The data controller is **Michele Uccheddu**, responsible for processing is **Michele Uccheddu**.

The data is collected directly from the interested party or from third parties due to legal obligations or contractual requirements, including through consultation of databases.

The Data Controller will be treated, in accordance with the Regulation and the national legislation in force, including any provisions issued by the Control Authority, where applicable, your personal data, directly provided by you or acquired through third parties.

In particular, the Data Controller mainly deals with the following categories of personal data:

- identification and contact details (e.g. name, surname, date of birth, address);
- images (e.g. videos and photos taken during the various activities, photos on documents; images recorded by surveillance cameras);
- data concerning psychophysical conditions, certifications or previous experience;
- any other data provided by the interested party.

The processing of your data is carried out by the Data Controller in carrying out its institutional and commercial activities for purposes related to: fulfillment of legal obligations, regulations and legislation; fulfillment of occupational health and safety obligations (e.g. safety training); exercise of a right in court; heritage protection (e.g. video surveillance of site accesses).

Your data may also be processed for periodic assessment activities of the existence of the ethical and legal requirements established by the Data Controller in its own Code of Ethics, as well as for the evaluation of the effective application of the Organizational Model pursuant to Legislative Decree 231/2001.

For the processing of data for the purposes indicated above it is not necessary to acquire a specific consent of the interested parties as the Owner can make use of the exemptions pursuant to articles 6.1 b), c) and f) Regulation.

The provision is mandatory only for data whose processing is imposed by a legal obligation. However, the provision of your data is necessary and, failing that, it will not be possible to follow up on your legally motivated requests, or give you the opportunity to enjoy rights under our law.

The undersigned is aware of his rights, namely:

You may exercise, in relation to the processing of data, the rights provided by the Regulation (articles 15-21), including:

- receive confirmation of the existence of your personal data and access their content (access rights);
- update, modify and / or correct your personal data (right of rectification);
- request the deletion or limitation of the processing of data processed in violation of the law, including those which are not necessary conservation in relation to the purposes for which the data was collected or otherwise processed (right to be forgotten and the right to limitation);
- oppose the processing (right of opposition);
- withdraw the consent, where provided, without prejudice to the lawfulness of the processing based on the consent given before the revocation;
- lodge a complaint with the Supervisory Authority in the event of violation of the rules on personal data protection;
- receive a copy of the data in electronic format concerning it rendered in the context of the contract and request that such data be transmitted to another data controller (right to data portability).

The data will be stored in compliance with the applicable legislation for the protection of personal data for the entire period of time necessary for to fulfill the purposes indicated above and in any case not beyond 12 months.

Only personal data functional to the fulfillment of legal obligations will be kept for the period of time necessary to comply with those obligations.

The data will be processed by the Data Controller and by persons authorized for processing under the authority of the same, mainly with electronic systems and manuals according to the principles of correctness, loyalty and transparency established by the applicable legislation regarding the protection of personal data and protecting the confidentiality of your data through technical and organizational security measures, to guarantee an adequate level of security (ad example by preventing access to unauthorized parties unless required by law, or the ability to restore access to data in the event of physical or technical accidents).
